# 1. APPOINTMENT OF CHAIRPERSON AND DEPUTY CHAIRPERSON FOR THE GENERAL FONO

The General Fono **appointed** Save Tumua as Chairperson and Tumua Pasilio as Deputy Chairperson.

Following appointment, the General Fono **observed** taking of oath by both the Chairperson and Deputy Chairperson.

#### 2. ADDRESS BY THE ADMINISTRATOR OF TOKELAU

Ulu o Tokelau, Hui o te Malo Fakaauau, Moheniolo, Toeaina, Hui o na Fatupaepae, Hui o te Fono Fakamua.

Greetings to all the servants of God gathered here to bring the wisdom of Tokelau to this General Fono.

I am very pleased to be here. I welcome this opportunity to address the General Fono and be part of your discussions over the next few days. I am also very pleased that I received the General Fono papers in good time, and have been able to prepare for the discussions.

When I met with the Taupulega recently, I heard that Tokelau sees New Zealand as your partner in the development of Tokelau. I heard the aspirations and priorities that Taupulega have for Tokelau's development. The emphasis was on initiatives that will have a direct benefit to the quality of life of villagers.

The people of Tokelau are New Zealand citizens who have chosen that Tokelau remain a non-self-governing territory for many reasons, including that the Administrator should walk alongside the elected leaders of Tokelau as they take up the responsibility of "prudent management of [Tokelau's] own and New Zealand's resources, for the benefit of the Tokelau people and in line with Tokelau's strategic priorities." As Administrator I am committed to working alongside the General Fono and Council for Ongoing Government as decisions are made and priorities are set.

Tokelau is changing its aspirations and priorities quickly and seeking New Zealand's assistance with specific projects in which New Zealand has technical or professional skills is essential if these priorities are to be met.

The goal of the Principles of Partnership is to "strengthen cooperation.... to maximise the benefits of the relationship... based on on-going and constructive dialogue (and)... operate on a 'no surprises' basis by maintaining clear and open communication."

I encourage you to hold a General Fono where officials and leaders can robustly debate what is realistic and best for Tokelau, and how those decisions will impact on Tokelau's future.

I will be with you for the next four years as you move forward. I will be working very closely with the Ulu o Tokelau and the Council for Ongoing Government to make sure that the Fono and Council have the best information and the fullest picture possible on which to make critical decisions about Tokelau's future. I will be working very closely with you, the Ulu o Tokelau and Council to make sure that Tokelau's governance and management processes are clear and consistently applied. I am focused on ensuring that decisionmaking processes are clear and help the Government of Tokelau to achieve its plans, and there are sound processes for ensuring elected leaders and public servants are accountable to the people of Tokelau.

Good investment decisions can be made only if the calculation of the benefits is realistic and all the upfront and ongoing costs of projects are realistically estimated and widely understood.

I look forward to conversation with you outside the formal sessions of the General Fono to help me to better understand how I can best support Tokelau's aspirations. There is much to be discussed here so I won't prolong my address.

Let me conclude by asking that God bless the deliberations of the General Fono and guide us in His wisdom.

Please note that Council has a responsibility to keep the Taupulega informed particularly on developments or activities to take place on atoll. In this regard, we seek that you acknowledge the Taupulega in the process of working together.

# 3. ALLOCATION OF MINISTERIAL PORTFOLIOS

The General Fono:

- ii. that discussions will continue how best ministerial oversight of Fisheries is addressed with the establishment and operationalisation of the Fisheries Management Agency and advice the General Fono at the earliest opportunity;

now been allocated to the ministerial portfolios of the Faipule of Atafu;

- iv. that allocation of portfolios must take into account experience and knowledge;
- v. that pending a paper being prepared by the Public Service Commission, the matter of the Department of Transport and Support Services is to be revisited given that two Ministers are responsible for one department.

ii. for the Administrator to prepare a paper in regards to the Fisheries Management Agency to facilitate addressing portfolio responsibility for the agency as soon as possible.

#### 4. INDUCTION FOR GENERAL FONO DELEGATES

The General Fono **noted** induction in relation to responsibility of a delegate and the importance of an ongoing programme to ensure that all delegates are fully aware of their responsibilities as a delegate.

#### 5. MID TERM BUDGET REVIEW 2016 - 2017

The General Fono:

- that remuneration for those directly working on capital development programmes should be covered by the \$1.4m [per village] for capital development;
- ii. the need for a provision as a Contingency Fund for emergencies;
- iii. that monthly financial reports should be received by departments and villages in a timely manner to ensure that budget managers are aware of their spending and remaining budgets;
- iv. the expected Revenue 2017 is \$35.8m,
- v. the Recurrent Expenditure budget is \$28.0m,
- vi. the budget expenditure for capital development is \$14.2m,
- vii. the budgetary deficit agreed to [by the Budget Committee] is \$6.4m,

- viii. the Financial Report for the Government of Tokelau, Revenue & Expenditure for the 6 months to 31 December 2016,
- ix. the requests for additional funding received by the Department of Finance,
- x. the prepared statement by the Department of Finance in regards to changes to the budget approved in July 2016 for the Budget 2016/2017,
- xi. that the General Fono called for a report in regards to the Repairs & Maintenance (R&M) programme for Tokelau.
- xii. that the remaining balance of \$200,000 from the total reductions of \$1,200,000 from the R&M provision and the villages is off-set by the reduction in expected revenue.

  - Note Transport overspending in the first 6 months to 31 December 2016;
- ix. *Increase* of Education Budget by \$40,000;
  - Additional funding for the Scholarship Scheme;
- x. *Increase* of Health Budget by \$100,000;
  - Additional funding for accommodation in Nukunonu;
- xi. *Increase* of funding to TeleTOK by \$400,000;
  - Additional funding for capital development initiatives;
- xii. *Incorporation* of 2016 brought forward balances to Atafu Capital Budget \$879,931;
- xiii. *Incorporation* of 2016 brought forward balances to Fakaofo Capital Budget \$134,174;
- xiv. *Incorporation* of 2016 brought forward balances to Nukunonu Capital Budget \$887,869
- xv. *Incorporation* of Nukunonu's 2016 underspending to it's Recurrent Budget 2017 \$79,631;
- xvi. *Incorporation* of 2016 balances for Education ito it's Recurrent Budget 2017 \$430,340;

[Incentivization Fund for teachers' salary increases - \$420,000; and Office for the Minister of Education - \$10,340]

- xvii. *Incorporation* of 2016 underspent brought forward for Health to it's Recurrent Budget 2017 - \$31,113;
- xviii. *Incorporation* of 2016 brought forward for OCOG into it's Recurrent Budget 2017 - \$80,000;
- xix. for the Department of Finance to provide a report on the national repairs and maintenance facility;
- xx. the revised total expected revenue of \$38,077,427 as detailed in *appendix 1*;

- iv. that in moving forward serious consideration be given to having other General Fono delegates as members of the Board given the increasing responsibilities of Council;
- v. the necessary changes required to the Transtok Rules in order for the effective operation of the Mataliki;
- vi. that the relevant sectors have been consulted.

# ii. endorsed:

- i. the inclusion of the Pulenuku in the Board of Transtok;
- ii. the proposed Transtok Amendment Rules 2017 as *appended*.

#### Appendix 1

Transport Tokelau Corporation Amendment Rules 2017

#### 1. Name

These are the Transport Tokelau Corporation Amendment Rules 2016

2. Rule 5.2 (ii) and Schedule are deleted and the following is substituted:

5.2 (ii) The conditions of employment of the crew members of Tokelau ships shall meet the standards of the Maritime Labour Convention 2006 and be in a form approved in writing by the Corporation.

3. Rule 7(5) is deleted and the following is substituted:

Rule 7(5) Till the endorsement of village Directors by the General Fono, the Board shall consist of the Council for the Ongoing Government.

4. Rule 8(3) is deleted and the following is substituted:

Rule 8(3) the Board must meet at least once every three months. In case there are logistical difficulties in arranging meetings of that frequency, the Board permits attendance at meetings by teleconference or audio visual link (such as Skype).

- 5. Rules 15 (1) to (5) ) are deleted and the following are substituted:
  - (1) The Corporation shall keep proper accounts and records of all its transactions and affairs.
  - (2) The accounts and records shall form part of the accounts and records of Government of Tokelau and all transactions shall be processed in accordance with the finance and accounting processes in place.
  - (3) The accounts of the Corporation shall be audited as part of the audit of the financial statements of the Government.
  - (4) The auditor or any person authorised by him is entitled at any reasonable time to full and free access to all accounting and other

records relating directly or indirectly to the financial transactions of the Corporation.

- (5) As soon as the accounts of the Corporation have been audited in accordance with these Rules, a copy of the audited financial results is signed by the Chairman, together with a copy of any report made by the auditor, shall be submitted to the General Fono.
- (6) (i) The General Manager shall prepare annual estimates of revenues and expenditures for presentation to the Board each year on or before the commencement of the last quarter of the current financial year.
  - (ii) The Board shall, following review and approval of such estimates, present these to the General Fono.

# 7. REPORT OF ONGOING BUSINESS

The General Fono:

- i. the Report of Ongoing Business;
- ii. the advice from the Administrator that positions within the Fisheries Management Agency (FMA) are currently being advertised;
- iii. that the Administrator will forward to Council a report on progress with the establishment of the FMA;
- iv. that the Report of Ongoing Business/decisions of Council need be provided to the Taupulega in a timely manner following each meeting;
- v. that matter noted at (iv) above has been discussed by Council and noted further that agreement has been reached that Council will meet every fortnight with reports conveyed to the Taupulega soon after with

intention that any views from the Taupulega can be raised and discussed at the General Fono;

- vi. requirement under rules remain that Council reports to the next General Fono;
- vii. that Council progresses implementation with little information being conveyed to the Taupulega;
- viii. that to ensure consistency in the information and understanding of the information being conveyed it is critical that a written report be provided to the Taupulega;
- ix. there may be some changes to the rules to align with requirement of the General Fono [Council reporting to the Taupulega];

#### ii. agreed:

- i. that decisions arising from each meeting of Council be conveyed to the Taupulega in keeping them informed of ongoing business;
- ii. to revisit the rules whether amendments are required to ensure alignment with (i) above.

#### 8. IMMIGRATION AMENDMENT RULES 2017

The General Fono:

#### i. noted:

i. the proposed Immigration Amendment Rules 2017;

- the view to increase the period for ordinary residence from 5 years to 10 years before one can apply for a Permanent Residence Permit;
- iii. that renewal of permit must be paid for before a current permit expires;
- iv. that the contracted workers should not apply for other contracted positions but should return to home base and reapply for another position should they wish;
- v. New Zealand officials and those travelling on behalf of external organisations do not require a permit however written advice to the Taupulega is required highlighting the purpose of their travel to Tokelau;
- vi. uncertainty as to whether any review has taken place in regards to non-nationals now living in Tokelau;
- vii. guidelines and criterion used by Taupulega varies hence critical that Taupulega agree to comply with those provided under the Rules;
- viii. that the Rules refers to Tokelau rather than each of the villages;
- ix. to review the rules as it refers only to immigration and not emigration;
- x. those contracted by individuals are required to pay for a permit;
- xi. a matter for consideration is whether Priests and Ministers of the Church should receive the same treatment under the Rules as those contracted by government or the villages;

- xii. a matter for consideration is a provision in the Rules that provides protection for the Taupulega;
- xiii. for children who are born in Tokelau to contractors should be of the same citizenship as the parents rather than by country of birth;
- xiv. the purpose of the proposed Immigration Amendment Rules 2017.
- xv. the proposed Immigration Amendment Rules 2017 serve to update the rules and clarify procedures;
- xvi. that consultations and discussions with the Taupulega will continue on Rule 8 in paragraph 2(ii) before submission to the next General Fono:

"Rule 8 of the Immigration Rules 1991 is amended-

- (i) in paragraph (1) (ii) by deleting of the words "in New Zealand":
- (ii) in paragraph (2) (ii) by deleting the words " NZ\$20 for each application lodged" and inserting in their place the following:

"-Visitor's Permit-NZD\$50

-Residence Permit-NZD\$50

-Work Permit – NZD\$100

-Special Permit- NZD\$100

-Permanent Residence Permit -NZ\$200;"

#### ii. endorse:

i. the Immigration Amendment Rules 2017 as *appended*.

#### **IMMIGRATION AMENDMENT RULES 2017**

- 1 These are the Immigration Amendment Rules 2017.
- 2 Rule 2 of the Immigration Rules 1991 is amended-
  - (i) by deleting of definition of "permit";
  - (ii) by adding the following definitions:

"Administration Officer' means the Director of support services of the National Government or the Village Officer responsible for Immigration.

"permit" means a permit refers to in Rule 7;

- 3 Rule 3 of the Immigration Rules 1991 is amended-
  - (i) by numbering the current provision (1);
  - (ii) by adding the following paragraphs-

(2) Where a person wishes to enter Tokelau as a Tokelauan, that quality must be established before travel to Tokelau.

(3) (i) Whether a person is Tokelauan or not is a matter for decision by the relevant Taupulega.

(ii) A decision of the Taupulega under this rule must be in writing and always available for inspection by the immigration authorities.

- (4) A person to whom this Rule applies shall provide the Taupulega with such written evidence of being Tokelauan as may be requested by the Taupulega.
- 4 Rule 5 of the Immigration Rules 1991 is amended -

(i) by deleting the words " A person who is not a New Zealand citizen" and adding in their place the following words " A person who is not a Tokelauan and who is not a New Zealand citizen";

(ii) By deleting subparagraph (ii) and inserting the following new subpgraph -"(ii)may not work in Tokelau unless that person holds a current permit that authorizes the person to work in Tokelau".

- 5 Rule 8 of the Immigration Rules 1991 is amended in paragraph (3):
  - (i) by numbering the existing provision (i): and
  - (ii) by adding the following subparagraphs:

(ii) The certification under this paragraph must be in writing and be always available for inspection by the immigration authorities.

(iii) The certification will be issued only after the Council for the Ongoing Government has received from the Government Department or Village concerned, written confirmation of the official business involved and the duration of the task.

6 Rule 8 of the Immigration Rules 1991 is amended by adding the following paragraphs-

(4) A person who enters Tokelau in accordance with paragraph(3) is not eligible for the issue of a permanent residence permit under Rule 7.

(5)(i) A permit exemption under paragraph (3) may include the spouse and children under 16 (of the person to whom the

exemption is granted) for a period not exceeding the duration of that exemption.

(ii) The extension under this paragraph-

- applies only where the entry of the spouse and children is specified in the arrangement with the village or government, and
- only where the permit exemption is longer than 2 months, and
- gives a right (for the spouse and children) only to reside in Tokelau.
- 7 Rule 9 of the Immigration Rules 1991 is amended -
  - (i) by deleting of paragraph (3);
  - (ii) in paragraph (4), by deleting "or a constable".
- 8 Rule 10 of the Immigration Rules 1991 is amended -
  - (i) in paragraph (3) by deleting of 3(iii);
  - (ii) by the addition of the following new paragraph-

(4) Every permit is valid for entry and re-entry to Tokelau while it is current.

- 9 Rule 20 of the Immigration Rules 1991 is amended by deleting the word "or a constable".
- 11The Schedule Form 1 of the Immigration Rules 1991 is amended by adding after the entry for Residence Permit, the following entry:

# PERMANENT RESIDENCE PERMIT

Current Permit-provide a copy of the current permit. Ordinary Residence Permit-provide a certificate of ordinary residence for the last 5 years issued by the relevant Taupulega. 12 The Schedule Form 2 of the Immigration Rules 1991 is amended by adding after "(insert a box) a residence permit the following entry "(insert a box) a permanent residence permit".

- xiv. Should consider activities that can be fully implemented properly in close partnership with New Zealand;
- xv. Should not rush but keep the Taupulega informed particularly with recommended focal areas;
- xvi. We use to collectively allocate budget support from New Zealand as well as our local revenue and we've since added an allocation for capital development;
- xvii. aspirations of Tokelau includes our elders and all our people on atoll;
- xviii. be mindful of information provided to the General Fono;
- xix. discuss with the Administrator in regards to financial assistance;

#### ii. agreed:

- i. to defer and refer to Council for discussion and in doing so to seek Taupulega views and resubmit to the next meeting of the General Fono.
- ii. for the Council to provide a report to the Taupulega and General Fono in regards to the Tokelau International Trust Fund.

# 10. NATIONAL CAPITAL DEVELOPMENT BUDGET: PURCHASE OF HELICOPTERS & PROCESS FOR UTILISING THE TOKELAU USD BANK ACCOUNT

The General Fono:

- clarification sought as to why issue of helicopters did not follow normal process in seeking blessings of the Taupulega instead of being taken by surprise by external media coverage;
- ii. that no report has been received and as conveyed by the Administrator a report on the helicopters in response to the Taupulega;
- iii. Council has not been able to respond to this issue and processes needs to be put in place to ensure that this does not happen again in the future;

- xi. No remit has been received whether amendment to the delegation of powers to the Administrator will progress without agreement between Tokelau and New Zealand;
- xii. For the Administrator to develop an appropriate Policy or Guideline for the utilisation of the Tokelau USD bank account for consideration and discussion by the General Fono.

#### ii. agreed:

v.

weeks:

- i. to commission an inquiry into the helicopter issue;
- ii. to refer to the Public Service Commission to carry out a review into the helicopter issue;

- iii. to sell the helicopters;
- iv. to defer to the Council to explore appropriate selling prices for the helicopter and inform the Taupulega as soon as possible;
- v. for the GM Apia, Director of Finance and the Minister of Finance as signatories for the Tokelau USD bank account;
- vi. for the Department of Finance develop to а recommendation as appropriate signatories for to operating the Tokelau USD bank account.

# **11. TOKELAU PUBLIC SERVICE REBORN**

- ix. The need for accommodation of public servants being relocated to Tokelau;
- x. Previous relocations may have had challenges [providing lessons that can be drawn on];
- xi. It is a challenge to the villages to prepare accommodation and office space for staff under relocation;
- xii. Explain the new department referred to as Department of Administration given that services are already undertaken by an existing department;
- xiii. All villages must stand and work together to ensure implementation;
- xiv. To amend timeline to refer to within 2017 as opposed to being specific to the first half of the year;
- xv. Funding for relocation is the responsibility of the department whose staff are being relocated;
- xvi. If there are challenges or concerns in regards to the plan then government must consider delaying implementation.

**ii.** in noting that the paper needs amendments following views expressed by the Taupulega, **endorse** the paper in principle in anticipation of the Public Service Commissioner consulting the Taupulega on the implementation plan.

## ADMINISTRATOR'S PARTING COMMENTS GENERAL FONO MARCH 2017

Ulu o Tokelau, Elders, Honourable Ministers, General Fono delegates, public servants and observers.

It has been a pleasure to be here this week to attend the inauguration of the Ulu and new government, and to attend the General Fono. This has been a time of celebration and ceremony, and we have experienced wonderful dance and song as well as great hospitality from the people of Nukunonu, who have ensured we have been well fed and well looked after! Thank you for the catering.

In the margins of this significant event, I have also met with the Council and with the Boards of the Transport and Teletok, and women delegates to the General Fono, and have had many conversations late in to the night with many of you individually.

I believe I have been witness to some significant new developments -in particularly a commitment by the Council to meet with the Administrator every fortnight as a mechanism to improve the progress of significant development projects; to ensure the work of government progresses at pace and according to sound processes; and to advance in with New Zealand.

This approach will ensure the interdependencies of initiatives and the work of the public service are more widely understood and managed. Importantly, the work of the SOE's as well as wider government will be bought to the Council – and from there Pulenuku will be empowered to regularly report progress and developments to Tapulega – keeping them up to date and informed of developments in a timely fashion. This should lead to a better government and informed decision making.

In leaving you at this stage of proceedings, I want to emphasise my personal commitment over the next four years, to working alongside you to ensure decision-making is sound, the decisions you make and their impacts are well worked through, and that the Principles of Partnership that guide the relationship between New Zealand and Tokelau, are upheld through my work as Administrator.

In all relationships, including in our families, there are be good times as well as challenging times – this is a fact of life. New Zealand and Tokelau have agreed that all issues should be resolved on a cooperative and collaborative basis, never taking our attention from maintaining and improving the quality of life of the people in the villages of Tokelau. Following recent setbacks, we have the foundation to take our relationship forward and the relationship between New Zealand and Tokelau will be characterised by mutual respect.

During my tenure as Administrator, New Zealand will continue to provide economic and administrative support for progressing Tokelau toward full self-government. I remain committed to that; to be hands on in my work; and to deliver results.

I will visit Tokelau regularly and hopefully bring my wife so she knows what I am experiencing and talking about. In the meantime, until I return, if you are travelling through Apia please call on me at my office in the New Zealand High Commission.

Kua gahe toto ia Mahu ma Mahu

E heki heua he gogo!

E heki mafulefule ia gutu o te ufu taia!

Being with us you are able to see for yourself the challenges that Tokelau faces in our journey for self government. Starting from the first day, I trust you witnessed Tokelau's efforts in moving forward.

Through you, please convey our thanks to the Government of New Zealand especially our friend Murray McCully for the ongoing support by New Zealand for Tokelau.

On behalf of the General Fono, our best wishes and may God guide you safely back to Samoa. We do note how difficult it is for you to find time to be with us given your busy schedule.

Thank you for being here. I trust that you have gained great knowledge and understanding of Tokelau as much as the General Fono has gained a greater understanding by your being here. We look forward to implementation of outcomes of this General Fono as we continue to work together.
